Plan Change: There will be a \$50 administrative charge for changes from one plan to another after May 1st

New Student Fee: New students are charged a one time non-refundable fee of \$675 per student

** A \$150 credit toward the New Student Fee will be given to all current PK3 students enrolling in PK4 (total \$525) **

Financial Aid: available to families who demonstrate need. The application process begins in January for the following school year
